Minutes of Van Zandt ESD #3 Meeting September 14, 2023

Tim Meredith gave his report for SVZVFD. After a discussion, Tim Meredith agreed to reimburse VZESD#3 \$47.96 for refreshments after a funeral (August, 2023 Ck #5035 to SVZVFD from VZESD#3). Meredith presented bills for payment:

The drought staffing approved in August meeting came to a total of \$4680.00.

Tim Meredith gave the financial report for SVZVFD. No action required,

Scott Opitz gave financial report for VZESD#3. He made a motion to move \$10,000.00 from the Capital Improvements account into the Emergency fund. Sue Baugh seconded the motion. The motion passed.

Scott Opitz reported from the outside auditors that we need to be amending our budget to reflect any overage of approved budgeted expenses.

Sue Baugh made a motion to accept the treasurer's report and to pay the bills. Heath Morris seconded the motion. The motion passed. The report showed the following checks:

Meredith reported the radios are going to be approximately \$8,000.00 over what was budgeted due to price increases. No action taken.

Marvin Shaw reported that the architect firm has split and he has cancelled the contract. He hopes to have a positive report by the next meeting.

There was a discussion on repairing the drive at Station #1. Tim Meredith presented 3 bids to cut out and replace concrete. The bids ranged from approximately \$2,000.00 to \$5,000.00. Marvin Shaw reported that Precinct #2 Commissioner has offered to patch hole with asphalt for free. No action required.

SVZVFD president Tim Meredith reported the new ladder truck is still not in-service. They are waiting on radios.

Marvin Shaw reported that the tax values are certified but not finalized due to the number of protests, but we are clear to proceed to adopt a budget and set a tax rate. Scott Opitz made a motion to adopt a working budget of \$795,578.48. Sue Baugh seconded the motion. Motion passed.
